

Steven Judy was a serial killer who murdered at least eight people in Louisiana and Indiana in the 1980s and 1990s. He was finally caught and sentenced to death in 1996.

* Judy was executed by lethal injection on September 21, 2003. * He was 47 years old at the time of his execution.




